SPACES ASSIGNED BY TYPE OF CRAFT & POST MARK DATE – no holds, no deposits, mail & write "CALL ME" if you are not sure.

SOFT JURY: VENDORS who have NOT been juried in the past 5 YEARS or have added NEW items OR New Crafter to your booth must:

EVERY 5 YEARS: 1) A ONE-TIME JURY FEE of \$20.00 EVERY 5 YEAR'S NOW! Using a separate check which is Non-Refundable.

2) 2/3 pictures of your art/craft work, 2 of exhibit/set up, & 2/3 PICTURES OF SUPPLIES & WORK AREA! Please/email or mail in.

EVERYONE: 1) SEND A SASE = Self Addressed Stamped Envelope (9 ½ x 4 1/8) Business Size for your Confirmation everyone must have one.

2) A \$10.00 CHARGE for NOT SENDING in S.A.S.E OR FOOD OR AGRICULTURE License Also! PLEASE SEND IN WHEN APPLYING.

3) A \$10.00 charge for NOT SIGNING YOUR Application. Please help us save time & office help, by Signing your Application.

4) I would rather you under pay then over pay, for \$20.00 or less will NOT BE RETURNED TO YOU! Thank you!

TRAVEL TRAILER HOMES: MAY BE PARKED ON OUTER EDGE OF PARKING LOT/ARTIST LOT/NO HOOK UPS – YOU MUST BE SELF CONTAINED!

CONFIRMATION: Sent within 90 Days of receiving payment, usually sooner. Confirmation will be needed for FRIDAY SET UP and early entry on Saturday & Sunday. A \$10 administration fee is charged for replacements, if Requested 30 days before show start date.

FOOD LICENSE: Vendors selling food must be licensed. Enclose a copy of your food license when submitting an application. Please wear gloves and you must keep foods needing refrigeration on ice. Vendors selling dog/cat treats require an agriculture license. Even for Sampling.

NSF CHECKS: A \$50 fee will be charged for checks with insufficient funds. This fee must be paid by money order within 10 days along with any other monies due in order to receive NEW Confirmation for a space in the show. A \$10.00 charge for no S.A.S.E. sent.

REFUNDS: Before 6/1/2019 a 50% handling fee charged on full booth price. No refunds after 6/1/2019. Confirmations must be returned With a LETTER explaining to Bev why you need to Cancel, and please Contact her, she is reasonable about cancelations.

SECURITY: Security will be provided for exhibitors from set-up to tear down. You must have your own insurance. Neither Eagle Take Flight nor Wings Event Center will be held responsible for unattended displays or stored items. You must have your own insurance.

CHECK-IN: "Check in Station & Envelope" By Overhead Door for Floors & Entrance to Wings Concourse from South Lobby Doors, Door #1, a Table is Set Up, please pick up your Envelope Here, if not we will come around before 7pm, so you do not lose your space. When you arrive ON FRIDAY 12/6/19 before 7PM nothing else needs to be done, once you have this envelope. NO SATURDAY SET UPS. FLOOR ARTISTS, MAY FIND THEIR CHECK IN PERSON AT A TABLE BY THE OVER HEAD DOOR, OR THEY WILL COME TO YOU.

WEEKEND OF SHOW: NO SASE IS REQUIRED, WE WILL PROVIDE ONE FOR YOU – YOU MAY ALSO BRING IT TO OFFICE – TO KEEP YOUR SAME SPACE #.

UNLOADING ARENA VENDOR'S: LINE UP on the NORTH SIDE of the Parking Lot CORNER OF "ZOO BUILDING" & NEXT to the I-94 Fence Line UNLOAD, then park up top, go back down and then set up. Others need to unload too. Thank you! FOR ONLY ARENA/FLOOR ARTISTS, AT THE END OF THE SHOW YOU WILL NEED A CARD TO GIVE TO THE PARKING LINE MAN/WOMAN TO GET INTO LINE.
